A new permanent crossing, to be laid in a trench 60m downstream of the former crossing is expected to be commissioned by NGC in late April.



# Hawkes Bay flood crisis

Gas supplies to the Hawke's Bay region were disrupted on 16 February 2004 when floodwaters destroyed a bridge carrying NGC's high pressure gas transmission pipeline across the Pohangina River, near Ashhurst.

The pipeline was still intact but was separated from the bridge and left suspended in turbulent water. This section of pipeline was isolated and partly depressurised for safety reasons and to preserve linepack in the pipeline east of Ashhurst. It was recommissioned to about half normal operating pressure on 20 February while a temporary aerial crossing using new pipe was constructed.

NGC contactors worked around the clock to complete the 120 metre temporary aerial

In order to help maintain gas supply, Vector, Powerco and NGC agreed the loan of Vector's six CNG tankers in order to provide customers with a temporary gas supply while the main line was repaired.

Five of the tankers and a regulating unit provided supply to the Watties plant and other parts of the network in the lower North Island. The sixth tanker and a second regulating unit supplied gas to approximately 300 customers in Ashhurst.

#### Horrocks medal – 2003 seminar

The judges for the Horrocks Medal at the seminar have recommended that no medal be awarded due to the criteria not being fully met – particularly the requirement for producing a technical paper. It needs to be noted that Council believes the presentations and topics at the last seminar were of a high standard and great value to our members and the industry as evidenced by the favourable comments received.

The Horrocks medal judging criteria puts emphasis on producing a technical paper in addition to the presentation. With the trend in recent years to power point presentations and a CD to increase the quality and professionalism of the seminar, there has been a move away from producing a traditional 'paper'. # A bit of history... "The Horrocks Medal"

Mr Harold Horrocks was employed by the Dunedin City Council in October 1913. In 1924 he was appointed Assistant Gas Engineer and promoted to Senior Gas Engineer in 1936. He announced his retirement on 31<sup>st</sup> October 1952 at the age of 65. The Dundedin City Council's

records show he stayed with the company until a replacement was found – he retired in February 1953.

Mr Horrocks was elected a member of the Gas Institute of New Zealand in 1925, a year after the Institute was founded. At a Christchurch conference he was elected President in 1947.

It is unclear exactly when but at some stage he left a sum of money to the New Zealand Gas Institute for the sole purpose of rewarding the best technical paper at the annual conference. At the time the best paper was to be determined by the "Executive Committee" of the Gas Institute.

Mr Horrocks passed away in 1981 aged 93. A moments silence was observed in the memory of Mr Horrocks at the 1982 spring technical seminar.

### Keeping safe... "Aerosol cans in vehicles"



The picture above is of a pressurised can that exploded in a person's vehicle and imbedded itself in the back seat of the car. The temperature outside of the closed up vehicle was about 38 degrees C. What if you or a loved one had been sitting in that seat?

Interiors of vehicles can reach extremely high temperatures when all windows are closed and sitting in direct sunlight.



The incident pictured above was caused by a deodorant spray can, which was left in the back of the vehicle that was parked in an open space in the middle of a hot, sunny day.

Without warning, the can exploded inside the car. Fortunately, no one was inside or near the car when it happened.

#### Recommendations:

- Do NOT leave pressurized containers (of any kind) in your vehicle where they can be exposed to sunlight!
- ➤ You should always read and follow the manufacturer's safety recommendations that come with the can.
- Reporting incidents such as this can help inform personnel of possible risks and dangers both inside and outside the workplace!
