
Richie McCaw & World of Groggs

2009 Spring Technical seminar

The 2009 Spring Technical Seminar is being planned to be held in Auckland although the dates and location have yet to be decided.

Although there is always a chance of a conflicting event impacting on the ability of members attending the seminar, Council will be confirming the seminar dates around March/April based on known events at the time, so if you know of planned or possible events in September/October 2009 please contact Geoff Evans with the details.

As we are likely to be formalising the arrangements for NZIGEM at the 2009 Seminar we are optimistic that IGEM will be in attendance, so their availability may be an influence in setting the dates.

Call for Presenters & Topics

It may be early but there is no time like the present, so if you would like to make a presentation at the 2009 Spring Technical Seminar or have an idea or concept that you consider would be of interest to delegates then please contact Geoff Evans or Greg O'Malley.

The comment has been made by the 2008 Horrocks Judging Panel that they would like to see a return to the seminar being a means for members to exchange ideas and present technical information from their own experience

which they could share with other members. It is acknowledged that a component of non-member participation also increases our awareness and knowledge so it does not need to be the focus.

Council endorses the views of the judges and although it isn't always possible, welcomes any suggestion or offers to present from our members, especially where it increases member participations at these events.

2008 Horrocks Award

Despite the excellent quality of the presentations the judging panel advised Council at the conclusion of the 2008 Spring Technical Seminar that they were unable to recommend awarding the Horrocks Medal for 2008.

Of the four members presenting this year none were eligible as three did not meet the requirement to provide a technical paper, and the one that did was unable to make the presentation.

It is acknowledged that the time and effort required in preparing and making a presentation is significant in itself and although we would welcome an increase in technical papers it would likely prove to be a disincentive to potential presenters if it were compulsory. Similarly it would devalue and be disrespectful to the Horrocks legacy and past medal recipients to remove the requirement for a technical paper, particularly given the objectives of NZIGE.

NZ Institution of Gas Engineers and Managers (NZIGEM)

It is pleasing to report that following recent discussions with IGEM and subsequent confirmation of the commercial arrangements, we are now able to proceed with the establishment of the NZ branch of IGEM offering the same membership benefits and cost as were offered previously.

By now all current members should have received our mailout inviting new applications or notification that a previous application is to be withdrawn. Based on the responses received at the time of preparing this newsletter it appears highly likely that we will meet the minimum membership of 40. If this is the case we expect to confirm the arrangements with IGEM and then

send out subscription notices in January 2009 for \$26 incl GST being the remainder of the subscription year (1 January – 31 May 2009). Membership fees for a full year will be \$62 incl GST with the same benefits of membership outlined in previous newsletters.

Workshops

A number of workshops were considered in 2008 although only one on high pressure custody transfer meter proving was held. Although faced with some technical issues on the day when linking up via the web to the Colorado Engineering Experiment Station in USA, the workshop which was already oversubscribed was a success.

NZIGE Scholarship

This year Council is again actively promoting the NZIGE Scholarship Fund and invites applications from members for sponsorship funding of up to \$2000.

Members may apply for a specific event that they have identified themselves or alternatively Council may nominate an event at a later date, but until such time as the funds have been committed for the year then applications can be submitted at any time.

In the consideration of granting Scholarship funds Council evaluates the benefits to the applicant's career and professional development, to members of the NZIGE and to the Gas Industry as a whole.

Through the provision of these funds, Council satisfies the objective of the NZIGE to improve and advance the technical training and general knowledge of our members.

Review of NZS 5442:1999

The revision of NZS5442:1999 Specification for Reticulated Natural Gas is now complete and available from Standards NZ, although it will not be effective until cited under regulations, expected in mid 2009.

Review of NZS 5258:2003

Further to the previous report that the NZS5258:2003 Standards NZ expert committee had decided to adopt the suite of standards developed by AG 008 to be known as AS/NZS 4645 Gas Distribution Management, these standards have now been successfully balloted and are expected to be published in early 2009.

Our thanks to Dan Hynson who was the NZIGE representative on the Joint Standards review committee.
